**Keywords:** This section describes the main issues of research, containing 3-5 words either single words or phrases, referring to the words in the title or implied in the discussion. Typed single spaced, Times New Roman, font size 10/11.

## **INTRODUCTION**

The introductory section contains (a) the background or reason why "x" is examined (2-3 most important), (b) the main theory, (c) the relevant previous research, and (d) termination of the research objective statement. In the introduction, there must be relevant references. The introduction has is no need for separate theory or library studies or subheading. The length of the introductory section is about 15% of the total number of article pages. Typed space 1.5, Times New Roman with size 12 font.

## **METHOD**

The research methods section includes (a) research approach and design, (b) data source/research subject/population/sample, (c) research instrument, (d) data collection techniques, and (e) data form. It should be detailed. The method list is sufficient in paragraphs, without subheading. In the method, is not required there is a reference. Referrals are required when there are explanations or unpopular methods. The descriptions in the method section should be typical or appropriate to each study, not method theory.
